

DEPARTMENT OF THE NAVY RESPONSE TO THE REPORT TO CONGRESS ON CY06 SEXUAL ASSAULT DATA

Policies, procedures and processes in place or implemented during CY06 in response to incidents of sexual assault involving Service members

NAVY RESPONSE

Policies issued include:

- OPNAVINST 3100.6H, "Special Incident Reporting Procedures" Clarifies command sexual assault reporting requirements. (2/06)
- OPNAVINST 1752.1B, "Sexual Assault Victim Intervention (SAVI) Program." Navy's comprehensive policy for sexual assault prevention and response. Formalizes all new DOD sexual assault requirements issued previously in Navy interim policy. (12/06)

The Navy Sexual Assault Victim Intervention (SAVI) Program strengthened structural and procedural changes implemented during CY05, transitioning the program from program management to case management.

- Increased staffing for installation Sexual Assault Response Coordinators (SARCs) was successfully incorporated into the budgeting and programming process.

SAVI Victim Advocate training materials were expanded and made more experiential to incorporate new DOD and Navy requirements. Training materials were vetted with Installation SARCs, Navy first responders (medical, legal and criminal investigators) and civilian advocacy organizations before production. SAVI Victim Advocate Trainer and Student Manuals were delivered in late CY06 to all Installation SARCs.

The Navy Fleet and Family Support Management Information System is being used to capture:

- Sexual assault training provided or facilitated by Installation SARCs or other Fleet and Family Support Program (FFSP) staff.
- Information and referral provided regarding sexual assault.
- One-on-one consultative assistance by the SARC or other FFSP staff to Commands and/or victims.
- FFSP clinical counseling services provided to sexual assault victims.

Standards pertaining to installation SAVI program requirements have been updated and are being reviewed as part of the FFSP Accreditation Process.

Navy FFSP launched a professional web portal that includes comprehensive sexual assault prevention and response information on a Navy SAVI Program home page (www.ffsp.navy.mil; Sexual Assault).

Installation SARCs were trained at two training venues:

- Navy-specific training was provided on the Defense Case Record Management System, implementation of new SAVI requirements, and effective Victim Advocate training.
- Navy also participated actively in the DoD Joint Sexual Assault Response Coordinator Conference.

Policies, procedures and processes in place or implemented during CY06 in response to incidents of sexual assault involving Service members (cont.)

MARINE CORPS RESPONSE

The Marine Corps continued implementation of Sexual Assault Prevention and Response policy outlined in Marine Corps Order 1752.5 and in accordance with DODI 6945.02. MARADMIN 564/06 was written to streamline sexual assault data entry into the Sexual Assault Incident Reporting Database.

Plans for CY07 related to prevention of and response to sexual assault involving Servicemembers specifically in the areas of: advocacy, healthcare provider/medical response, mental health, counseling, investigative services, legal services, and chaplain response

NAVY RESPONSE

Implementation of the DOD Defense Case Record Management System will greatly enhance quality assurance and requirements compliance review by SAVI Program oversight staff. Standardized training development for Installation SARCs includes:

- SAVI Command Roles and Responsibilities for SAVI Command Points of Contact
SAVI Command Liaisons and the Data Collection Coordinator

Tool development:

- SAVI Program Implementation and Resource Guide for SARCs
- Commander's Toolkit

MARINE CORPS RESPONSE

The Marine Corps Sexual Assault Prevention and Response (SAPR) Office will develop a plan to implement annual SAPR refresher training for law enforcement personnel. An Automated Inspection Reporting System has been developed to inspect installations for SAPR program compliance.

NAVY AND MARINE CORPS JUDGE ADVOCATES RESPONSE

There are additional plans to address sexual assault in CY07 since data on the number of sexual assault victims who received legal services in our offices is not collected. Although legal services are available to eligible sexual assault victims, by policy, no information has been collected on the services provided to such victims.

Provide information on the capacity to respond to sexual assault affecting members of the Armed Forces reporting requirements, specifically:

The number of personnel trained to be 'first responders' to sexual assaults (including criminal investigators, medical personnel responsible for rape kit evidence collection, and victims' advocates)

NAVY RESPONSE

First Responder Training during CY06:

- 65 Installation SARCs
- 2500 SAVI Victim Advocates

MARINE CORPS RESPONSE

First Responder Training during CY06

- 64 SARCs
- 1350 Victim Advocates/Uniformed Victim Advocates
- 1009 PMO
- 65 CID
- 280 Chaplains (Serve Navy and Marine Corps)
- 122 Staff Judge Advocates

NCIS RESPONSE

- 96 investigators received advanced training in CY06 on "Sexual Assault Investigations and Victim Interviewing" courses.

BUMED RESPONSE

Approximately 20-30% of all Military Treatment Facility personnel have received first responder instruction. Presently, Navy Medicine Commands are utilizing various options to train first responders such as Navy Knowledge On-line (NKO) or in-person presentations. These approaches are not standardized and may even vary within a command depending on available resources including NKO accessibility. BUMED instruction 6310.11 is being revised to align with the DODI 6495.02 which should facilitate improved reporting in the future greatly. Navy Medicine Manpower, Personnel, Training and Education Command is assigned the implementation monitoring and reporting responsibilities outlined in the DODI.

The number of victims whose care was hindered due to lack of available Sexual Assault Forensic Examination (SAFE) kits or other needed supplies

NAVY AND MARINE CORPS RESPONSE

This information is not collected by the SARCs or Victim Advocates. The Navy's position is that BUMED should collect all information pertaining to the use of SAFE kits.

The number of victims whose care was hindered due to lack of available Sexual Assault Forensic Examination kits or other needed supplies (cont.)

NCIS RESPONSE

NCIS does not collect this information and is unaware of any victims whose care was hindered by lack of available sexual assault forensic evidence (SAFE) kits. The new DON Criminal Justice Investigation System will have the capability to collect this information.

BUMED RESPONSE

BUMED does not collect information on the number of victims whose care was potentially hindered in regards to the lack of available SAFE kits or timely access to appropriate lab testing resources. It is BUMED's position that the collection of this type of information is under the purview of the Sexual Assault Response Coordinator (SARC) who is designated by the installation commander and is not necessarily attached to an MTF. The SARC, through the use of the Defense Case Record Management System (DCRMS) is tasked under the DoDI 6495.02 to monitor program performance including any problems with services delivery to the victim. To address your concerns, we will plan to examine ways to coordinate formally with the SARCs to receive timely negative feedback on health care services rendered to victims.

The number of victims whose care were hindered due to the lack of timely access to appropriate laboratory testing resources

NAVY RESPONSE

Navy does not collect this information. See answer on page 3.

MARINE CORPS RESPONSE

Due to California Penal Code requirements that healthcare providers report to law enforcement any wounds/physical injuries inflicted by another as a result of assaultive or abusive conduct, some sexual assault victims have been delayed a Sexual Assault Forensic Exam (SAFE). Because Camp Pendleton Naval Hospital does not conduct the examinations on base, victims are sent to civilian hospitals for all SAFEs. However, all victims received the requested exams within 24 hours.

NCIS RESPONSE

NCIS is unaware of any victims whose care was hindered due to lack of timely access to appropriate laboratory testing resources. The current NCIS database systems were not designed nor equipped to track laboratory processing timelines or whether a victim received a SAFE kit. The new criminal justice database system being developed will enable the tracking evidence from submission for analysis to receipt of laboratory finding. This system will be implemented throughout DON in CY07.

Implementation of the tracking system for perpetrator prosecution

NAVY AND MARINE CORPS RESPONSE

Perpetrator prosecution tracked via existing SJA and NCIS protocol on release of case disposition information.

Implementation of the plan to provide trained personnel, supplies and transportation to deployed units to provide appropriate and timely response to reported cases of sexual assault

NAVY RESPONSE

Marine Corps response pertains to Navy personnel assigned to Marine Corps units.

MARINE CORPS RESPONSE

The Commanding General for the deploying command is required to have a forward Sexual Assault Response Coordinator (SARC). The forward SARC is tasked to create an execution template for handling a sexual assault incident including the transporting of a victim from one location to another to undergo a safe examination. Deploying battalion/squadrons are required to have a minimum of two UVAs. UVAs are trained to provide immediate assistance to sexual assault victims within their command. SAFE kits are a part of the attached medical assets Table of Equipment (T/E).

Supply inventory results and location/availability of supplies, trained personnel and transportation resources to support deployed units in responding to cases of sexual assaults

MARINE CORPS RESPONSE

Currently within the AOR of Iraq the ability to perform SAFE examinations exists at the Level II facilities of Al Asad and Teqatum. Also, the Army's 31 CASH can perform the exams. Information on supply inventory results is not available.

NAVY EDUCATIONAL TRAINING COMMAND CY06 TRAINING ON SEXUAL ASSAULT

RECRUIT TRAINING COMMAND

Sexual Assault Prevention and Education training is delivered to recruits at Recruit Training Command (RTC) and to those in officer accessions training.

GENERAL MILITARY TRAINING (ENLISTED AND OFFICER)

Delivered to all hands at all commands. Covers Navy Core Values; definitions; OPNAVINST policy and procedures; UCMJ and civilian law; and access to support organizations and counseling.

- FY06 GMT – continued reinforcement of sexual assault awareness, prevention and response. Learning objectives include:
 - Define sexual assault and differentiate between different types of sexual assault.
 - Identify key players in the Navy SAVI program and have a thorough understanding of their functions.
 - Explain Navy's policy on sexual assault and recent changes to SAVI program due to DOD standardization requirements.
- FY07 GMT/SDC (Sailor Development Continuum) – topic under development. Focus will be:
 - Practical Applications
 - Risk Management
 - Reporting Options

PREVENTION, RESPONSIBILITY, ETHICS AND VALUES EDUCATION/TRAINING (ENLISTED)

PREVENT is a 3 day course targeted towards the prevention training needs primarily of those Sailors in the 18- to 23-year-old age group. In addition to a strong emphasis on alcohol and drug avoidance and prevention there is a unit on interpersonal responsibility.

NAVY EDUCATIONAL TRAINING COMMAND CY06 TRAINING ON SEXUAL ASSAULT

ALCOHOL AND DRUG PREVENTION TRAINING

All ADAMS courses, DAPA and Alcohol Aware point out the dangers of sexual assault as a consequence of drug and alcohol misuse. While sexual assault prevention and response are not the focus of these training events, opportunity is taken to underscore the causal factors alcohol and drug consumption play.

ENLISTED AND OFFICER NAVY LEADERSHIP CONTINUUM TRAINING

Currently, none of the enlisted or officer leadership development courses specifically address Sexual Assault Prevention from a structured training perspective. There are case studies in our courses that can lead to a classroom discussion on the topic of Sexual Assault, but Sexual Assault Prevention is not a specific learning objective in any of the case studies. The IG does present a brief that includes Sexual Assault Prevention to all the leadership courses at the Command Leadership School. SAVI is covered in the Senior Enlisted Academy, Command Master Chief (CMC)/Chief of the Boat courses. CMC is responsible for monitoring.
